The interbank rate increased to **6.11%** from **5.87%** recorded on Thursday. This indicates a tight liquidity in the market as the government continues to mop up liquidity in the market through the open market operations.

EQUITIES



FIXED INCOME MARKET:

Secondary bond market turnover was down 23.64% to record KES 1.85Bn from KES 2.42Bn recorded last Friday. The number of deals decreased to 27 from 743. The FXD2/2013/15Yr was today's most traded bonds.

DAY'S FEATURE: Banks' loan provisions decrease as NPL's increase.

In 1H19, banks in overall recorded an increase in NPLs and Net Profit and a decrease in loan provisions. Loan provisions reduced by 8% to 14.1Bn, NPLs increased by 11.4% to 348.2Bn and the net profit increased by 14.2% to 67.1Bn from 58.8Bn.

Tier I banks recorded a decrease in provisions by 3.7% from 9.2Bn to 8.89Bn while its gross non-performing loans increased by 12% to 179.6Bn. Tier II Banks recorded an increase in provisions of 2.15 to stand at 14.19Bn and its gross NPLs also increased by 1.3% to 116.2Bn.

Tier III bank on the other side experienced the highest decrease of 48.3% in its provisions to stand at 1Bn from 1.99Bn despite the rise in its gross NPLs. Their combined net profit for 2.96Bn from a loss of 254.7Bn.
