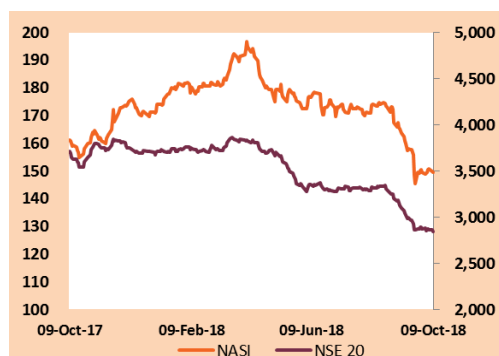

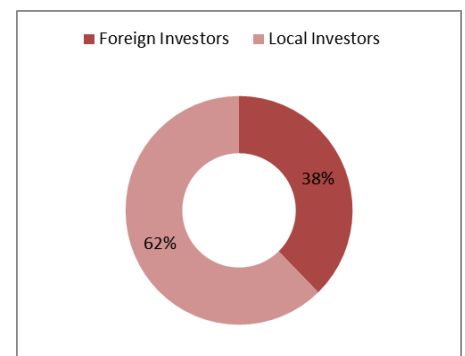
Market Index Movement
